



Ammunition Sales Certification Agreement

Before your first order of blank ammunition can ship, customers who are not licensed Federal Firearms License (FFL) Dealers must fax, email, or mail a copy of the following documents to us (we will hold your order until the documents are received).

Boland Production Supply, Inc. ("BPS") must receive a copy of the Buyer's state-issued driver's license or state-issued identification card to verify date of birth AND a signed copy of this Ammunition/Hazardous Materials Sales Certification Agreement. If your state requires a separate state-issued license to purchase ammunition, then that document must accompany this form.

To order blank ammunition, you must read and agree to the following items:

- 1.) I am age 21 or older;
- 2.) I am not prohibited from purchasing, possessing, using, owning or storing this product because of a criminal background, drug use, family violence protective orders or other prohibitions placed on me;
- 3.) I understand that blank ammunition is non-returnable;
- 4.) I understand no refunds shall be issued as a result of Buyer non-compliance with their local and state laws concerning the purchase or possession of ammunition;
- 5.) I am not a fugitive from justice;
- 6.) I have not been convicted in any court of a crime punishable by imprisonment for a term exceeding one year;
- 7.) I am not under indictment for a crime punishable by imprisonment for a term exceeding one year;
- 8.) I am not an unlawful user or addicted to any controlled substance (as defined in section 102 of the Controlled Substances Act);
- 9.) I have not been adjudicated mentally defective;
- 10.) I will not allow a minor under the age of twenty-one (21) to transport, receive, possess, handle, store, use and/or dispose of this item/product in accordance with the laws of my current state of residence and/or state of intended use;
- 11.) I realize blank ammunition is inherently dangerous and I personally accept full responsibility and full liability for the safe transportation, receipt, possession, storage, use and/or disposal of this product in accordance with the laws of my state of residence and/or state of intended use;
- 12.) I understand that discharging, cleaning, or handling ammunition, components and/or firearms may cause exposure to lead, and I agree to hold BPS harmless and I assume full responsibility for such exposure;
- 13.) I agree to hold harmless Boland Production Supply, Inc., including the owners, employees and assigns, for any damage to property, bodily injury, including death, as a result of my actions while using this item/product;
- 14.) I hereby represent it is my responsibility to check for any local, state and/or federal laws prohibiting this product and/or its purchase, transportation, receipt, use, storage and/or possession:
 - CALIFORNIA: No sales of ammunition to the City of Los Angeles, all of Orange County, or San Francisco without an FFL.
 - ILLINOIS: Residents shall include a copy of their FOID card AND a Driver's License or State ID, and the ammunition may only be shipped to an address shown on either of those documents. No ammunition sales to Cooke County or the City of Chicago.
 - MASSACHUSETTS: No sales of ammunition or components to Massachusetts residents. Ammunition sales only to 01 FFL Dealers with resale certificate.
 - NEW JERSEY: Ammunition sales only to 01 FFL Dealers with resale certificate.
 - NEW YORK: No ammunition sales to New York City. Check other local and state laws before ordering.
 - WASHINGTON D.C.: No sales of ammunition or components.
